The undersigned, having been first duly sworn according to law, deposes and says:

1. That an application for a Kennel License has been made to me by the Holmes County Auditor.
2. That the kennel for which the License is requested is owned by a person, partnership, firm, or corporation professionally engaged in the business of breeding dogs for sale and that such breeding is done for gain and not hobby. I also understand that the State of Ohio no longer identifies dogs used for the purpose of hunting as a kennel (ORC 955.02), therefore, individual tags must be purchased for hunting dogs and any other dogs that are not identified by the ORC definition of a kennel. Per ORC 955.02 "Kennel means an establishment that keeps, houses, and maintains adult dogs, as defined in section 956.01 of the ORC, for the purpose of breeding dogs for a fee or other consideration received through a sale, exchange, or lease.
3. That the Kennel License application is being made in good faith, and not for the purpose of avoiding the licensing requirements for dogs in the State of Ohio.
4. That I understand and consent to the fact that the Kennel for which the application for a Kennel License has been made is open for inspection within one year from the date of this Affidavit by the Holmes County Auditor, or her designated agent. If a determination is made that any material statement in this Affidavit is false, the Kennel License will be revoked.
5. I certify that I understand and meet all the requirements of statements one through four.
